## ATTACHMENT TO APPLICATION FOR APPOINTMENT TO THE APPRAISAL REVIEW BOARD

To be eligible for appointment an applicant must be a current resident of El Paso County and have been a resident for a minimum of two years immediately prior to applying.

You are **ineligible** to serve if:

- you are employed by the Texas Comptroller of Public Accounts;
- you are a member of a governing body, an officer, or a full or part-time employee of a county, city, school district, community college district, MUD, or any other entity supported by local property taxes;
- you own an interest in property on which delinquent taxes are due regardless of where in Texas that property may be located, unless the tax is deferred or being paid under an installment agreement;
- you or your spouse personally has a contract with a local government or an appraisal district. The same restriction applies if you or your spouse, own a 10% or greater interest in a business that contracts with a local government or taxing unit;
- you have at any time appeared before the Appraisal Review Board for compensation;
- have ever been employed by the El Paso Central Appraisal District or have ever served as gnember of the District's Board of Directors;

Also, individuals are not considered if they are presently under indictment or have been convicted of a felony or a misdemeanor involving moral turpitude.

PLEASE NOTE: If you are a former member of a governing body or an officer of a taxing unit served by the El Paso Central Appraisal District you are ineligible for four full years from the date you cease to serve in that capacity.
